## Instructions for use.

1. Read the declaration carefully! It is legally binding.
2. Fill out all the fields
3. Email or post the completed form back **8 weeks** before the event complete with a £25 deposit. (Payment may be by cheque made payable to Hire and Fire Ltd or by BACS to Hire and Fire Ltd, A/c 72973093 sort 40-51-62. Final payment to be on the first day of hire.

4. On the day of hire bring with you the documents you mention in the form. Do **NOT** send original documents or copies. Bring **ONLY** originals on the day.
5. All forms **MUST** be filled out **legibly!** Preferably in block capitals.

## Declaration


I hereby declare that I am not a prohibited person under the 1968 Firearms Act and Amendments. I have no outstanding criminal convictions and have not served any prison sentence. Furthermore, to my knowledge I have no current charges or pending charges nor am I currently under investigation either in the UK or overseas.

I further confirm, that to the best of my knowledge, that I have no underlying medical condition that would preclude me from handling firearms.

I confirm that I am 18 years of age or older.

In signing the underlying document I confirm that at no time whilst the firearm is in my possession will I allow any unauthorised person to handle it, nor will I at anytime allow the firearm to be out of my custody and will remain responsible for the safety and security of the firearm until returned to an officer of Hire and Fire Ltd.

I also confirm that I will at no time handle the firearm in a manner that endangers myself or others.

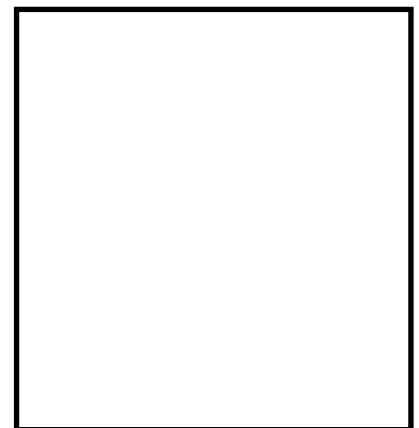

Under no circumstances is a hired firearm to be removed from the hire venue.

### Incident reporting

The hirer is to inform a member of the Hire and Fire Limited armoury team of any incident or dangerous occurrence involving a firearm hired from the company at the earliest opportunity.

All hirers of firearms will be briefed on generic firearms safety procedures.
